



# The Dog Patch Agreement & Waiver Form

Please initial that you have read and understand each point - please ask for clarification if necessary.

By signing this document I, as the owner/agent/guardian, guarantee that I will be personally liable for all expenses resulting from daycare, boarding, veterinarian fees, property damage fees or any other expenses incurred while my dog is visiting or being boarded at The Dog Patch Daycare.

I represent and warrant that my dog is in good health and has not been ill with any contagious condition or otherwise in the last 30 days before his/her admittance to The Dog Patch Daycare.

\_\_\_\_\_

I also represent and warrant that all required vaccinations (DHLPP, Rabies and Bordetella) are up to date and is current on Flea/Tick Preventative Medication and that I will provide proof of the vaccinations (vaccine record/certificate).

\_\_\_\_\_

I understand that while my dog is fully vaccinated that vaccines are not 100% fool proof and there is still a risk (albeit minimal) that my dog may contract a contagious virus/disease. I agree that should this occur I am responsible for my own pets' care and medical attention.

\_\_\_\_\_

I agree to allow a 7 days waiting period after my dog has had his/her vaccinations to allow the vaccines to reach full protection potential and to ensure my dog has not had any negative reaction to the vaccines. Should I allow my dog to stay at The Dog Patch Daycare earlier than after a 7 day wait period I understand that my dog could be at risk of contracting a contagious virus/disease.

I represent that my dog will be evaluated and deemed suitable for daycare/boarding.

\_\_\_\_\_

I represent that my dog is sociable and has not harmed or shown threatening behaviours towards any person or any other dog. I understand that should my dog display any unwanted behaviours while in the care of The Dog Patch Daycare that staff will remove him/her from the play area.

I understand that The Dog Patch Daycare is a cage free daycare facility. I accept all risks involved and agree that The Dog Patch is not liable for any injuries or illnesses during my dog attendance.

\_\_\_\_\_

I understand that although all dogs are fully supervised that incidents of injuries may occur. This includes that my dog could receive bites, scrapes and scratches from his/her playmates.

\_\_\_\_\_

I agree to disclose any previous or current medical issues/concerns of my dog so that the Dog Patch Daycare staff can make a determination of suitability for daycare/boarding.

\_\_\_\_\_

I allow The Dog Patch Daycare staff to contact my/a veterinarian as deemed necessary should any injuries require medical attention. I agree that I am responsible for any medical bills acquired for my own pet.

I hereby release The Dog Patch Daycare from all liability for any loss or expense that I may suffer or bear as a result of any happenings (such as disappearance, runaway, sickness, injury, death from any cause, fire, theft etc.) through transportation or otherwise during the time that my dog/cat is in the custody and control of The Dog Patch Daycare.

Although The Dog Patch Daycare carefully screens all applicants the facility is occasionally discovered not to be an appropriate environment for every dog/cat. The Dog Patch Daycare reserves the right to refuse service and permanently evict any dog/cat at any time and for any reason without explanation.

I hereby approve that my dog/cat be videotaped and/or photographed and/or recorded. The Dog Patch shall be the exclusive owner to the results and all proceeds of such media and may post on The Dog Patch social media.

I hereby decline my dog/cat appearing on The Dog Patch social media.

I certify that I have read and understood the terms as set forth herein and that I have read and understood this agreement. I agree to abide by all The Dog Patch Daycare and accept all the terms, conditions and statements of this agreement and confirm the truthfulness of the contents of the application form completed by me.
